1. Perception,
2. Mental Imitation (the ability to capture and represent the sharpness of the details of the shape/sound of an object),
3. Mental Imagery,
4. Visual Imagery,
5. Language Interpretation (Linguistic Ability).

We become intelligent because our active thinking ability (operative intelligence) sends the meaning obtained into our figurative thinking process. Intelligence is a combination of abilities, skills and habits (abilities, skills & habits) which are formed as a result of the transformation of the assimilation of perceptions that always occur actively in our daily lives.

Jean Piaget, The Late French Cognitive Constructivist, stated that intelligence is active and dynamic, and is a representation of the processing of thought that occurs figuratively, so that understanding can be formed.

Every time, operative intelligence frames our understanding (framework of knowledge) about the world. Our intelligence will change when we cannot understand the transformation that occurs. Piaget stated that this process of understanding and change involves two functions, namely the assimilation function and the accommodation function.

- Forcing people to submit themselves towards their sets of conforming of largely false dogmatic beliefs.
- Making people unaware and unsensitive of the severity of false moral belief, of the severe violations of laws, and
- making people forgot about their own basic virtues, and

- making people tendencies inclined in upholding their own principles.
- Making people unconscious that they have done many moral violations in many of the behaviour that they have done.
- Creating the decreasing of social perception sensitivity
- Creating certain paradox of realities into something that being unaware anymore.
- Set back the formations of modern upholding of moral cognitive development, far back plunge into the forming of early cognitive primitives.
- Doing the spread of negative cognizant of social incremental reasoning
- By creating many unimportant news as headlines to creates social cognitive vagueness in the society
- Setting back the social cognitive priority from pursuing the fulfilling of basic necessities into chasing unimportant matters
- Creating the inclinations of political objectives from the necessities of opening vast progress in accelerating industrial development into chasing wars and creating regional conflicts towards nations that located in proximal directions.
- Creating false belief in the societies, usually used by children to explain an object they see or to tell their own experiences, without the usage of theoretical foundations lies beneath.
- Creating their own symbolic language and means of communication to interact and commanding and

directing certain kinds of retaliations, intrusions of peace, etc.

- Creating their own code of cognitive operations Thought processing that are applied to directively mastermind scenario on creating certain an event or to a particular object to be happening without doing anything.
